## **Vocational Development Grant Application**

## Please read these guidelines prior to completing this application form:

- 1. LWPT was established to give assistance to emerging leaders in UK based churches. We do this by 1) encouraging better communication for Bible teachers, 2) producing resources that support them and their congregations and 3) offering tuition grants to help Bible teachers (preachers, home group leaders, evangelists etc) to pursue further studies.
- 2. This form will enable you to apply for a "tuition grant" but, as you complete this application, please keep in mind the following criteria that LWPT use in assessing whether a tuition grant can be offered to an applicant:
  - a. You may study outside the UK (UK based studies are preferred) but your ministry after graduation must work itself out in a **UK based local church**.
  - b. We may occasionally support further "Masters" studies but not PhDs. We are focussed on supporting emerging leaders pursuing diplomas, certificates and undergraduate degrees.
  - c. You must show proof of **seeking funds from other sources**. We do not want to be the only source of your financial support.
  - d. We offer 2 levels of grants: A maximum of £2,000 towards tuition fees and a maximum of £500 for books/resources in any one financial year (1<sup>st</sup> September to 31<sup>st</sup> August). We will accept applications for both levels of grants on one application, but please be aware that the value of each grant awarded will vary depending on need. Please clearly state the sum you are applying for.
  - e. We do not commit to more than one year of tuition grants. If you are awarded a grant, please do not assume that we will be supporting you again in future years. Grants depend on available funds as well as the quality of the other applicants applying when you apply again.
  - f. Grant recipients are welcome to apply for additional grants providing they continue to meet the relevant criteria. Applications can be made twice within one financial year, but will only ever be awarded the total maximum amount of £2,500 within that year.

#### Who is eligible?

Applicants should be committed Christians and active members of a church.

Information regarding financial circumstances will be requested in order to help us determine the need for support.

#### Support for the application from a referee

To be considered, the person making the application requires the support of a member of their church staff, who will be asked to supply a reference confirming the applicant's interest and potential ability in preaching, their Christian faith and their character.

## Purposes for which the grants may be used

Grants may be used toward the cost of course or conference fees or materials. Grants may not be used for board or subsistence.

The organisation or training provider must be recognised by LWPT as providing relevant and valuable experience or training. There is no definitive list of such organisations, but rather each case will be considered on its merits.

## The application process

Grants are awarded twice a year.

Meetings usually take place in June and November for grants to then be awarded in August and January.

Please note: closing dates for applications are 3 May and 3 October.
